The Stewards, having received a report from the EMSO Chief Marshal in regards to an incident during the period of the red flag while cars were parked at the grid, have interviewed the Marshal involved, summoned and heard the Competitor and the Driver, reviewed the matter, determined a breach of the regulations has been committed by the competitor named below and have decided to impose the following penalty:

No / Driver 44 / Neale Muston

Competitor ARC Bratislava

Time 16:20

Session Race 1 (During the Red Flag period)

Facts During the red flag period when all the cars where lined up at the red flag line on the grid, the driver was witnessed by a track marshal urinating behind a post. As it was a female marshal who noticed, she immediately called the attention of a male marshal to discourage the action.

Offence Articles 11.9.3.l, 12.2.1.k of the FIA International Sporting Code.

Decision A fine of Euro 20,000 imposed on Neale Muston.

Amount of which, Euro 10,000 is due with Euro 10,000 suspended until the start of Race 2 subject to the submission to the Panel of Stewards of a written apology addressed to the Emirates Motorsports Organization. Failure of which, will require payment of the suspended portion of the penalty.

Reason In certain cultures where acts or deeds vary in levels of acceptance, the Panel of Stewards recognize that in the United Arab Emirates, such an act is extremely disrespectful and is a criminal offense.

The Competitor is reminded of their right to appeal the decisions of the Stewards (with the exception of those referred to in Art. 12.3.4 of the FIA ISC and Art. 16.2.6 of the Asian Le Mans Series Sporting Regulations), in accordance with Art. 15 of the FIA ISC and Article 9.1.1 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
