APPLICABLE REGULATION

Article 6.3.4 2021-2022 Asian Le Mans Series Sporting Regulations

DECISION

To provide fair racing in a transparent manner, ACO BOP decisions for Asian Le Mans Series and publication will follow the process defined below:

1) Communication process

- Every manufacturer must appoint a single representative to discuss BOP matters. Competitors willing to provide input on BOP can only do so via their manufacturer representative. The manufacturer representative must be appointed to the Asian Le Mans Series Committee before January 30th 2022.
- Any communication regarding BOP must be done:
 - o In writing, via e-mail
 - o Sent to the Asian Le Mans Series Committee (comite.asian@lemans.org). Per article 6.3 of the Sporting Regulations, the Asian Le Mans Series Committee is the sole body competent to rule on BOP
 - o Cc'ing
 - The Technical Delegates of the Series: David Hache d.hache@lemans.org and Rémi Sudre r.sudre@lemans.org
 - All representatives from manufacturers entered to the Serie (full season and race-by-race)
 - One representative from each Competitor entered to the Serie (full season and race-by-race)
 - o Deadlines listed in this decision must be strictly abided by manufacturer representatives

NB: if any of the above or following requirements are not fulfilled, the communication will be discarded.

2) First competition of the season

The BOP table for the first competition will be published at least two weeks before the start of the concerned Competition.

If any comments are to be processed on the published BOP before the first competition, they will have to be sent before January 30th 2022.

3) Following competitions

The BOP table for the second competition, if any change, will be published at least on Tuesday February 15th 2022.

No BOP comments will be processed between the date of publishing and the start of the Competition.

Any decision taken by the Asian Le Mans Series Committee is not subject to appeal.

4) During a Competition

BOP decisions can be modified during a Competition, at the sole discretion of the Asian Le Mans Series Committee.

If any comments are to be processed on the BOP of the first race of the first competition; they will have to be sent before 10:00 pm (UTC+4) on Saturday February 12th 2022.

If any comments are to be processed on the BOP of the first race of the second competition; they will have to be sent before 10:00 pm (UTC+4) on Saturday February 19th 2022.

5) Post-Competition review process

Manufacturer representatives will be allowed to provide analysis or complementary information to the Asian Le Mans Series Committee on Monday February 14th. Feedbacks must be documented and supported by data or timing information.

6) Disclaimer

BOP decisions are taken and published at the sole discretion of the Asian Le Mans Series Committee and are based on conclusive input from the ACO Competition department.
